- ① "2012 Hard Conversion" refers to a conversion where one-to-one correspondence is made between the altered contents in 2011-version Chinese Import & Export Tariffs and those in its 2012 version;
- 2 "2012 Soft Conversion" refers to a conversion where appropriate adjustments are made to the alterations under "2012's hard conversion" upon their conversion into Chinese Import & Export Tariffs in the light of China's taxation and trade policies, duty rates, import/export volume, and so on.

The correlations of Chinese sub-headings and tariff rates for 2012 aim at facilitating the HS code conversion and is for your reference only.
